The Property

The property is entered via double doors from the front into a bright and spacious main shop area with six large windows providing lots of natural light. This bright and airy room has hardwood flooring, timber panelling and central heating radiators and provides access to a kitchenette and WC. The kitchenette has ample floor and wall units with sink and drainer and space for an under counter fridge. Decorated in neutral tones with tiling to splashback areas. A WC is located to the side with window and is well presented in neutral tones with vinyl flooring.

From the main shop area, a door leads through to an office room with windows to the side. Decorated in neutral tones with hardwood flooring and is flexible in use. To the rear is a large store area with shelving and windows to the side. The property can be entered from the rear also via the large and welcoming communal hallway.

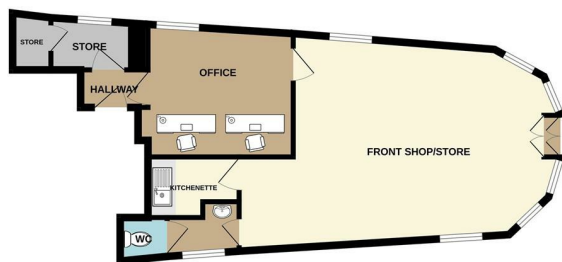
